

Office of Rural Health

- The geographic isolation of rural areas creates different circumstances and challenges for people who live in these communities.
- Rural communities differ from urban communities in four distinct ways:
 - demographic composition
 - social ties and social capital
 - culture
 - infrastructure and institutional support

- The White House Rural Council aims to address challenges in Rural America by streamlining and improving the effectiveness of federal programs serving rural America and coordinating private sector partnerships."



Journey began in 2010

Pilot Project for Mental Health Consultations

- University of Kansas Medical Center's Area Health Education Center located in Pittsburg
- Sedan City Hospital

Between late 2010 and early 2011 conducted 10 consultations

Early 2011 to Fall 2012 for VA to develop and approve a contract

.....only with University of Kansas Medical Center Area Health Education Center located in Garden City

Between fall 2012 to mid-March 2013 conducted 25 mental health consultations

Lessons Learned

- Very slow process
- Review proposed VA contract very carefully
- Include VA clinical provider in all discussions with VA regarding actual consultation
- Obtain list of VA staff involved with consultation process and make contact with them
- Determine fee (if any) for clients that do not keep appointment
- Determine invoicing and reimbursement process prior to initiating consultations

Benefits

- Provides a much needed service
- Partnership between federal agency and a state agency
- Leverages an infrastructure that already exists
- Revenue generating
